





Lessons from the Assembly polls

(Insider Bureau) The writing was quite evident on the wall but the Congressmen feared to read them. The grand-old 127 years old party had started crumbling from within but the leaders chose to ignore that. The symptoms of structural failure and chinks in the armour was becoming too glaring and yet the leadership kept brushing that under the carpet. The steam of local and state level leadership are started drying up fast and yet no effort was made to reclaim or energize it. The Congress party's traditional vote bank has already vanished and the young voters have turned away from it.

All these factors together have started becoming a Frankenstein for the Congress leadership and with Rahul Gandhi card having become ineffective and inadequate in arrest the saffron surge across the country, the Congress leadership appears to have once again plunged into throes of crisis of credibility.

The BJP on the other hand, has emerged more strong and Gujarat Chief Minister's relentless campaign against the Congress party has clearly made an impact. Modi's pincer attack on the Prime Minister and the Gandhis has started creating nationwide ripples and his crusade on corruption and various scams during the UPA II regime has already started alienating the middle class voters away from the Congress.

Modi's nationwide appeal may have been laughed at by a few congress leaders yet the fact remains that he has played the role of a positive catalyst for the BJP. His campaign across the country has indeed fired-up the BJP and the RSS cadre and that is going to help the party in the coming days.

Secondly, Modi's star power and charishma in rallying various groups which have been traditional BJP supporters is going to strengthen the BJP further and the young voters in particular.

Moreover, Modi has been instrumental in guiding and goading those floating and undecided voters to fall into the BJP kitty and that has been a major factor in the victory of BJP in the State Assembly elections.

On the hindsight, it is not that Modi is not helping the BJP win everywhere as some of the BJP leaders are making a case for him. Modi has just become a symbol of popular antipathy to the Congress and its top leadership and he is just reaping the harvest of discontent shown by the Congress in UPA II regime.

Catharsis in Congress

Different States, different players, different playgrounds, different rules and yet the same result. !!. It is time for the Congress leadership to sit back and dispassionately analyse as to what has been destroying the Congress? Why is the party losing everywhere? Why it has walked away from the needs and aspirations of AAM AADMI? Why Congress Rahul Gandhi has failed as a leader? Why Congress poll managers have become so staid, slate, inefficient and incompetent in gauging the mood of the electorate? Where would it go from here and who would lead the party now in the forthcoming Lok Sabha Polls?

Whatever logic and explanations may be given by Congress leaders on camera yet the fact remains that nothing has worked for the Congress in last four years. Be that Bihar, Uttar Pradesh, Gujarat, Punjab, Goa and these five states including Chhattishgarh, Madhya Pradesh, Rajasthan, Delhi and even Mizoram, nothing has worked for the Congress party. If this could be hailed as the semi-final, then there are clear indication that the Congress party would struggle to even get into three digits in the forthcoming polls and it would have tough time in getting into two digits in the Hindi heartland.

The Congress party could have easily snatched Madhya Pradesh and Chhattisgarh from BJP but it lost its path mid-way. It was in

opposition in both States and it had everything to gain from voter fatigue against the government. The Congress party had a big advantage in Chhattisgarh in the first phase but it got smug and slackened in the second phase and that gave a big opportunity to BJP to consolidate its position. There was an undercurrent of sympathy for the party in the Chhattisgarh and yet it could not capitalize on it.

In Madhya Pradesh, the Congress party could not stir up corruption and bad governance in Madhya Pradesh and "undeclared war between Suresh Pachauri and Digvijaya Singh faction apart from snipes at Jyotiraditya Sindhia took away the advantage. Media publicity and State level campaign remained lethargic and the Congress party could not pin down BJP governments in Madhya Pradesh with aggressive campaign material.

In Rajasthan, the government was in power and it had a credible face in Ashok Gehlot. The government acted like Santa Claus for almost two years distributing the wealth of the State with both hands in the name of welfare schemes and yet the party faced a rout. The party could not publicize its achievements in Rajasthan and interference from central leaders only added to the chagrin of the Chief Minister.

There was no unanimity among the Rajasthan chief Minister, Dr CP Joshi and AICC general secretary Gurdas kamat on many issues and even the last minute intervention by Shri Gulam Nabi Azad could not stem the tide against the Congress. Moreover, Rebel candidates and dummies (propped by a few congress leaders) also became a source of headache for the party in some areas.

In Delhi, The party had a charismatic leader in Shiela Dixit with a proven record of good governance. Arvind kejriwal's AAM Admi party(AAP) not only made the contest triangular but also divided the Congress vote to an unimaginable extent. Moreover, Chief Minister's quote to electronic media on possible tie up with AAP, was taken with a bag full of salt by many voters. At the end, Chief Minister Sheila dixit not only lost her own seat but the Congress party could not get into double digit.

But the biggest disappointment was the "failure of Rahul Gandhi weapon" which the party had hoped to use as a 'game changer". This was vindicated by a very senior Congress leader in a private conversation who said that "The Congress party can keep foisting Mr Rahul Gandhi on the electorate and we can never dare oppose him because he is the scion of the party's first family. But it is clear that people are not prepared to accept him in the current Avatar. The sooner our party accepts this, the faster it can start re-building itself".

Rahul Gandhi's close confidants have always been using the term "game changer" more often to demonstrate that his ideas and ideals are different from the present dispensation. Results of this round of assembly polls have once again proved that it did prove to be a "game changer" but in reverse. Instead of mobilising the electorate and translating them into vote, Rahul Gandhi's "poori roti Khayenge. Congress ko Jitayenge(Borrowed from Indira Gandhi election manifesto) in fact, boomeranged on him and his party. Now, the Congress party think tank would be forced to either abandon the term 'game changer' or would have to look for

fresh ideas and epithets... and better plan and projects to reclaim the term.

Congress party insiders admit that " As heir to the Nehru Gandhi dynasty, there are but two possible reasons for the party to look to Rahul Gandhi. One was their belief in the possibility of Rahul Gandhi's ability to enthuse voters on the basis of his pedigree while the other was

that that he may be able to revitalise a decaying party organisation through his more scientific plans and preparations. "

But a look at the rallies of Rahul Gandhi in a few rallies clearly indicate that he is not a man who has a natural connect with crowds. "He lacks the fluency and charisma that marks a politician who can excite or charm an audience. His mannered behaviour, his stiff body language and his inability to speak Hindi in a fashion that the audience can relate to, has clearly put paid to any expectation of mass support" says a veteran political commentator.

It is no coincidence that by far the greater part of his energy ever since Mr Gandhi entered politics, has been given over to this effort. On many occasions, he has proved to be an enigma and surprised both his friends and foes alike with his quips and quotes on some important issues. And it is here that his failure is most evident, and provides the clearest evidence that it may be best for the party to look beyond Rahul Gandhi.

More than that however, it is the systematic organizational failure and decay within the Congress party which appears to have landed it in such a precipice and for that many people would have to take the collective blame. Says another political analyst "The fall of Rahul Gandhi as a leader is not the only problem with the Congress party, Manmohanomics and Sonianomics too have to take an equal share of blame for the present mess".

There is a lot of truth in this statement. First, a look at a few statements made by Rahul Gandhi in recent times. Rahul's gaffe about intelligence agencies briefing him about plots by terror outfits to lure Muslims victims of communal violence in UP raised many hue and cry and quite ostensible so. Apart from the stigmatization that the victims could do without, questions were raised about Rahul's easy claim that intelligence agencies were briefing him when they had no business doing so because neither he is the Union Home minister nor the Prime minister. A national newspaper also published a report alleging that that there had been a large-scale of misuse of intelligence agencies to screen possible congress candidates at the behest of Rahul Gandhi and his team.

Second, Rahul Gandhi also kept reminding voters in his speeches that Land Acquisition Bill was his idea and that he had personally toiled on foot from Bhatta Parsaul to NOIDA in Uttar Pradesh to understand the set of issues related to land acquisition and then pushed the UPA to adopt this idea as Law. He wanted the compensation of the required land to be raised four times the market value in rural areas and twice the market value in urban areas.

But his think tank members perhaps

failed to make him understand that the landed gentry was well-entrenched in the political game and knew how to play it in its best interests. Business and industry was already opposed to it as it would inflate costs and make the acquiring process so cumbersome that no new ventures would be practically possible. Even Congress President Sonia Gandhi and the rest of Congress party workers remained blissfully oblivious to it and the net result was a dud. !!

Third, Rahul Gandhi also tried to woo the voters in MP and Rajasthan through tearjerker narration of his mother's illness and Mrs Gandhi's regret of not carrying her resolve to press the button during voting in parliament for the Food security Bill. He tried to evoke and connect the sympathetic and emotional chord by narrating how assassination of his grand-mother and father impacted his life. Even his belligerent" tear and throw the nonsense ordinance' approved by his own party government failed to impress the voters.

Dichotomy between words and Deeds

Rahul Gandhi has always said that he wanted to usher in more democratization in the party and was a votary of giving way to younger faces in elections. But the end result of all such exercises have been confusing and at times, contradictory to his statements. For these Assembly elections, the process of selection of candidates has been entirely the work of Rahul and his team, with the Central Election Committee (CEC) headed by Sonia Gandhi virtually serving to endorse the selection. A report in The Indian Express quoted a CEC member as saying that, "At CEC meetings, names are taken and cleared almost like a ritual as we know Rahulji and his team have done the background check through independent surveys, intelligence agencies and various other sources. Madam (Sonia) does not intervene anymore and watches the proceedings silently.

A few members of team Rahul also suggested that he has always favoured credible young faces. Yet the biggest howler on this score was the Congress party's decision to give ticket to a 80 year old Ameri Devi, the mother of Malkhan Singh Bisnoi who remains the main accused in Bhanwari devi abduction and murder case. In Delhi, Sajjan Kumar's son was given Congress party ticket even as the Supreme Court has ordered the commencement of yet another trial for murder against his father. That was interpreted as Congress party's strange way of making amends to the Sikh community in an election where it has been making so much of noise about its concern for the minorities and no wonder then that the Congress lost State Elections miserably.

Even otherwise, this kind of "top down selection approach" puts paid to the hype of inner party democracy. Rahul's major achievement in terms of party reorganisation seems to have been to place great reliance on people like him who have inherited the privileges of power. In Rajasthan for example, both Sachin Pilot and Bhanwar jitendra Singh were made co-chairmen of the poll campaign committee. "This multiplication of imitations of Rahul across the party has virtually ensured that there are no grass root leaders of any importance emerging from within the party structure. At the very least, the result of Rahul's intervention should have been the selection of candidates who represent the new and progressive face of the party" said a Senior Editor of a Prominent Hindi daily from Jaipur.

A principled course



The Aam Aadmi Party has creditably been unswerving in its refusal to accept offers of support from the major political parties, the Congress and the Bharatiya Janata Party, to form the next government in Delhi. By staying true to his pledge not to support either party in the event of a hung Assembly in Delhi, AAP convener Arvind Kejriwal has shown himself to be a person of principles. He has acknowledged that the mandate for his fledgling formation reflected public faith in the AAP's platform. Sunday's fractured verdict placed Mr. Kejriwal on test and his challenge is to resist a continuing flow of inducements from the two other contenders. Having sold a dream to its voters with the promise of clean and principled politics, the AAP cannot afford the slightest misstep in this regard, risking the tremendous goodwill that has brought it so close to power. The AAP was born out of a social movement that tapped into public impatience with the politics of corruption and compromise. Anna Hazare who led the movement drew his credibility from being viewed as a renunciate with no self-interest, but only a deep and abiding commitment to cleanse the system. However, movements are by definition transient, and Team Anna crumbled in the face of the UPA Government's intransigence on the Jan Lokpal Bill which was at the core of the agitation.

When Mr. Kejriwal parted ways with Anna Hazare, it appeared that the movement for political renewal was in serious jeopardy. Yet, if Mr. Kejriwal managed to change that moment of despair into one of hope, it was because he realised the futility of grandstanding from a distance and saw the need to transform the social stirring that drew upon so much idealism and hope, especially among the youth, into a live political battle with the entrenched mainstream political parties. The voter interest in the AAP was on account of its perceived idealism rather than the bagful of populist promises it offered. Mr. Kejriwal owes it to his voters — and the country at large — not to betray their faith in his party. It is important that the AAP sticks to its principled platform, the centrepiece of which was the passage of the Jan Lokpal Bill, intended to bring into existence an independent body which on the basis of complaints from the public could independently investigate corruption cases against political leaders and government officials. The AAP has said that it would sit in the opposition in the Delhi Assembly and not indulge in any "horse-trading". It is vital now than ever before that the AAP keeps its word, if it intends to retain credibility in the long term. -Editor

Not Congress

If there is a message that binds Sunday's set of four assembly poll verdicts, it is that of the voter's alienation from the Congress, her growing anger with the party. While each scorecard will be read more closely to coax out its specific messages, the expression of a building anti-Congressism rings out across the different political contexts and states. Its most remarkable image belongs to Delhi, where three-time chief minister Sheila Dikshit has been defeated by debutant Arvind Kejriwal of the AAP, which has also laid her government low. But it is anti-Congressism again



that accounts for the yawning gap between the party and the victor, the BJP, in Rajasthan and MP, with the Congress only seeming to put up a fight in Chhattisgarh. In the end, it might be an overstatement to attribute the BJP's showing in the four states to the aggressive campaigning by Narendra Modi, given the energetic role played by local leaders in states where it has notched its decisive victories — though the results are certain to lend force to Modi's prime ministerial campaign. But the electorate's rejection of the Congress needs no local nuancing. The party has no fig leaves to hide behind — neither a rote law of anti-incumbency, nor the difference between the voters' calculus for the assembly and general elections, can explain the humbling.

These elections have injected some new questions in the polity. Could it be that an anti-corruption platform can be a winning one, in more cynical times, more than two decades after V.P. Singh deployed it to trounce Rajiv Gandhi in the 1989 elections? Or, can a political force born of a disavowal of politics eventually grow into a political alternative that also bridges caste and regional divides? And, is it possible that the politics of populist schemes has also bumped up against its limits, just as identity-centred politics did before it? This last question is most starkly framed in Rajasthan. Here, outgoing chief minister Ashok Gehlot's array of supposedly crowd-pleasing sops and schemes was capped by the promise to provide 35 kg of wheat free to all families in the state, except income tax payers. The Congress washout here is a warning against an electoral strategy that relies on an indiscriminate, blind populism.

U.S. Center for Disease Control Awards Grant to Queens College

Goal of Research Project Is to Improve Working Conditions in Post-Disaster Settings

(Press Release) New York–The destruction of the World Trade Center has shown that conditions after disasters can be very dangerous, both short and longterm, for the workers involved in cleanup and reconstruction. Post-Superstorm Sandy workers may also be facing threats to health and safety.

Now, thanks to a federal grant of \$547,000, the Center for the Biology of Natural Systems (CBNS) at Queens College of the City University of New York and the immigrant- focused organization Make the Road New York, that will be less likely to occur. This two- year grant, which began September 30, 2013, was awarded by the National Institute for Occupational Safety and Health



(NIOSH) of the Centers for Disease Control (CDC) to conduct research on improving working conditions for immigrant construction laborers in post-disaster reconstruction. It is part of the federal government's response to the needs created by Sandy's devastation. This project will fill important gaps in knowledge about the prevalence of unsafe working conditions in this post-hurricane environment and will develop and test methods of addressing those hazards. Says Steven Markowitz, M.D., director of the CBNS: "Given what we all learned from the illness of workers engaged in clean-up of Ground Zero, it is critical to prevent post-disaster workers from becoming ill when we are uncertain about the hazards. We do this by educating them and providing them with proper protective equipment." Make the Road New York works with immigrant laborers in Queens, Staten Island, and Brooklyn, as well as Brentwood (Long Island), Once recruited for this project, the laborers will be trained and will conduct more than 200 worksite safety and health hazard assessments. Whatever is preventing, or helping to ensure, safe work conditions will be identified through focus groups and interviews.






(By Our Staff Reporter)THE wisdom of surveys often provides us insightful peeks at prevailing attitudes to different phenomena. In that light, sex surveys, saucy reads as they are, hold a mirror to the society, especially one as beset by patriarchy as India's.

Little wonder then that when the India Today Group, along with the marketing research organisation MDRA, set out to unmask Indians' changing attitudes to sex, their questions threw up some worrying answers even as they revealed how people in our country are getting more experimental with the art of intimacy.

The inherent tendency for victim- blaming is reaffirmed by the fact that of the 1,999 men surveyed across 19 cities, a staggering 36.3 per cent blamed a woman's revealing clothes for rape. While 33.3 per cent said rape could be attributed to the rapists' perversion, only 4.6 per cent believed male chauvinism played a role.

Marital rape, on the other hand, appeared to be no concern at all for most of the male respondents, an astounding 79.3 per cent of whom said it was their right to have sex with their wives. As many as 48.1 per cent even admitted to "sometimes" insisting on intercourse irrespective of whether their wives were in the mood or not.


More than 13 per cent confessed to doing so "often". The survey also brings into question the common perception that education is the panacea for all of India's ills, with results showing that the belief that revealing clothes invited rape was stronger among people who had completed higher levels of formal education. Around 45 per cent of people with postgraduate degrees in professional fields were found to hold this opinion, as opposed to 35 per cent among Class XII passouts.


The deep- seated orthodoxy evident in this response also seemed to be the determining factor for the respondents' attitude to premarital sex. Of the 2,015 women surveyed, again across 19 cities, a resounding 74.3 per cent admitted they expect the man they marry to be virgins. They fared only slightly better than men, 77.4 per cent of whom expect their prospective wives to have "saved herself", as the common euphemism goes, for after marriage.

Among the male respondents, no less than 76.1 per cent said they would never marry a woman they know has had premarital sex. Of the entire pool of respondents, 44.8 per cent termed the entire concept of premarital sex " wrong". Paired with findings suggesting a more adventurous attitude to sex — 28 per cent of the female respondents admitted to masturbating as compared to 9 per cent in 2003, when the first India Today sex survey was conducted — the survey puts the verdict clearly on the wall.

Indians have a long way to go before women are allowed a say over their bodies and sex shorn of the stigma.

Till then, the status quo will be questioned, one sex survey at a time.

IOC to revoke India's suspension after IOA elections

(Agencies) Indian athletes have been cleared to compete in the Winter Games in Sochi after the country complied with the IOC's ethics rules and avoided becoming the first country expelled from the Olympics in more than 40 years. Still to be determined is whether the few Indian athletes who have qualified for Sochi compete for their country or under the Olympic flag.

The International Olympic Committee gave a reprieve to India's suspended national Olympic body on Tuesday after a long impasse that had threatened to lead to the expulsion of the world's second most populous nation. The move came two days after the Indian Olympic Association amended its constitution to bar any officials charged with a crime from running for election, as demanded by the IOC. "We think that is a major step in the right direction," IOC president Thomas Bach said. "We are now looking forward to the implementation of the new rules by transparent and open and democratic elections in the Indian Olympic Association."

The Indian body was suspended by the IOC last December after electing secretary-general Lalit Bhanot, who spent 10 months in jail on corruption charges related to the 2010 Commonwealth Games in New Delhi. Mr. Bach said the IOA remains suspended pending the holding of elections under the new constitution. Although the new elec-



tions will not take place until Feb. symbols 9, two days after the start of the Sochi Olympics, Mr. Bach said the IOC has "taken precautions for the athletes and made sure the athletes will not suffer from this procedure."In that case, Mr. Bach said, Indians would compete as

symbols allowed at the venues or opening ceremony.

If the elections can take place before the Sochi Olympics and satisfy the IOC demands, the suspension would be lifted and the athletes could compete with their national flag and anthem.

India is likely to send a three-member team to Sochi, led

by luger Shiva Keshavan, who will be participating in his fifth Winter Olympics. Keshavan, who set a continental record at the Asia Cup in Nagano, Japan, last December, is hoping to become the first Indian to win a medal at a Winter Games. India can also send one male and one female Alpine skier to the games.

Nassau County police Commissioner ousted

(News Agencies) Mineola-Nassau County Executive Edward Mangano has replaced Thomas Dale, the county's top law enforcement official after prosecutors found police Commissioner Dale personally directed his officers to board a county bus in October and arrest a witness in a politically motivated election-year case. In a statement, Mangano said he met with Dale, who he hired as commissioner in January 2012, on Thursday morning and the commissioner tendered his resignation.

Dale, who will not be charged by District Attorney Kathleen Rice, will be replaced on an interim basis by Victor Politi, Mangano's deputy county executive for public safety. In a letter to Mangano Thursday outlining her office's findings, Rice said no laws were broken and Dale will not be charged.

"District Attorney Rice today brought a troubling matter to my attention regarding questionable influence within the Nassau County Police Depart-

ment," Mangano said in a statement. "Upon further investigation, the district attorney found no evidence to indicate criminality but the investigation itself indicates a fresh look at internal procedures is warranted. This approach is necessary to maintain the highest standards of police internal administration. New leadership sends a clear message that stringent administrative review and application is underway." Two other top police officials involved in the bus incident --Chief of Detectives John Capece and Sqt. Sal Mistretta -- have left the department, according to officials. Capece retired and Mistretta resigned. Capece will be replaced by Narcotics Vice Squad Insp. Kevin Smith. The case involved

Randy White, 29, of Roosevelt, who testified that former Freeport Mayor Andrew Hardwick was paying him \$1.25 for each signature he got on petitions for Hardwick to get on the ballot for Nassau County executive. Petitioners legally can be paid per hour but not per signature. Hardwick has denied the claim. White was arrested Oct. 5 while riding a bus from Roosevelt to Hempstead. He had failed to pay a \$250 fine after pleading guilty earlier this year to selling bootleg DVDs. In the letter to Mangano, Rice said Gary Melius, owner of the Oheka Castle catering hall and a Hardwick campaign donor, called Dale to report that the campaign wanted to file a perjury charge against White. After conferring with police personnel, Dale told Melius to report his allegation to the First Precinct in

Baldwin, Rice said. Dale instructed Capece and a department lawyer to report to the First Precinct and meet with a Hardwick attorney and several campaign operatives regarding the perjury complaint.

"While the political sensitivity of Mr. White's case may very well give rise to appropriate administrative and public scrutiny surrounding the decision to prioritize the search and arrest of Mr. White, the department's decision to target the subject of an open warrant was not a violation of criminal law," Rice said in the four-page letter. Melius said neither he nor Dale did anything inappropriate. "I did not ask Dale to do anything wrong and he did not do anything wrong," Melius said Thursday.

Rice found that Mangano was not aware of Dale's actions.

YOU STILL CAN'T TAKE CHANCES So what can you make out of the mumbo jumbo of contradictory scientific studies? Even the researchers doubt if this gold standard study decriminalising mobiles will end the debate on them.

Our suggestion would be to take the news with a pinch of salt for different reasons such as: mobiles are a relatively new technology, scientific studies take time and brain tumours for example, grow slowly. Also, most

government agencies prefer to tread a safer approach.

Even the WHO calls for further research on the health risks of mobiles. While the body of research is extremely reassuring on the lack of its health consequences, the final word is awaited as scientific evidences aren't good enough to give mobiles a clean chit yet. But we can very well keep off scaremongering and falling for potshots on our favourite gadget.

Let's accept it: whether or not mobiles cause cancer, there is no moving back from the technology at hand. The ubiquitous device is indeed indispensable.

So, lets do ourselves a favour by using this marvel responsibly, without affecting our health and well-being.

World Bids Farewell in the Land Mandela Freed

(Agencies) SOWETO, South Africa — For a day, the world came to Nelson Mandela's adopted hometown. There were celebrities: Bono, Naomi Campbell, Charlize Theron. There were kings-in-waiting: Crown Prince Haakon of Norway and Crown Prince Felipe of Spain. There were more presidents and prime ministers than at just about any other setting outside a United Nations General Assembly. It was a singular gathering to celebrate a life virtually unmatched in modern times, and the assemblage of allies and adversaries reflected Mr. Mandela's enduring legacy of forgiveness and reconciliation, as well the messy and sometimes clashing global allegiances of his party, the African National Congress.

President Obama gave a eulogy that stirred the crowd, only to be followed later by President Raúl Castro of Cuba. The two even shared an unexpected handshake. Old friends met happily in the V.I.P. area, while old enemies, like former Prime Minister Tony Blair of Britain and President Robert Mugabe of Zimbabwe, avoided each other.

"It took a man like Madiba to free not just the prisoner, but the jailer as well; to show that you must trust others so that they may trust you; to teach that reconciliation is not a matter of ignoring a cruel past, but a means of confronting it with inclusion and generosity and truth," Mr. Obama said in his remarks, referring to Mr. Mandela by his clan name. "He changed laws, but he also changed hearts."

Sheets of driving rain swept across this former segregated township — an urban sprawl within sight of the glittery high rises of downtown Johannesburg - keeping many mourners away from the vast soccer stadium where Mr. Mandela made his last public appearance, during the World Cup in 2010. Still, tens of thousands of other South Africans, swathed in their national colors, came out to celebrate Mr. Mandela, who died on Thursday at the age of 95, some stomping their feet as protesters did during the movement that led to his release from prison in 1990 after 27 years of incarceration. "Even heaven is crying," one woman in the crowd declared as the deluge continued. "We have lost an angel."The day began with a joyful noise. Nothando Dube, 31, left her home in Soweto at dawn, joining a throng to sing old songs of the struggle against apartheid, waiting for the memorial to the man who brought democracy to South Africa and became its first black president. It was a moment for a country that at times still seems deeply divided by race, class, religion and tribe to join together once again as the Rainbow Nation of Mr. Mandela's dreams.

"It feels different when you sing it now as a free young person," said Ms. Dube, wearing an A.N.C. beret. "You try to reach that feeling, that emotion they were feeling when they sang that song in prison."

But a few hours later, her mood had darkened. As jeers cascaded from the crowd aimed at South Africa's current president, Jacob Zuma, Ms. Dube was one of many rolling their arms in the gesture known the world over as a call to substitute a failing player in a soccer match. It was an unmistakable message to Mr. Zuma, who faces corruption charges and deep worries about his governing of the country.

"You don't want to be airing your laundry in front of everybody, but people wanted to send a message," she said. "The man on the street feels there's a lot that should have been done by now to fix the country."Like many around the world, the United Nations secretary general, Ban Ki-moon, praised Mr. Mandela's ability to look beyond past wrongs, bridge divisions and build a new nation, inspiring his own country and many others far beyond its borders. "He showed the awesome power of forgiveness - and of connecting people with each other and with the true meaning of peace," Mr. Ban said in his remarks. "That was his unique gift, and that was the lesson he shared with all humankind. He has done it again. Look around this stadium and this stage. We see leaders representing many points of view, and people from all walks of life. All here, all united."

But what had been planned as a moment to reunite a nation struggling with a slumping economy, widening inequality,



rampant corruption and deep political divisions ultimately showcased the broad discontent with South African politics today. Many attending the service booed and hooted at Mr. Zuma, who has for many come to symbolize all the lost promise of South Africa's peaceful transition from racist white rule to nonracial democracy. "I don't own a house even though I am always struggling," said George Tshotlego Mikobeni, 27 and unemployed, as he watched Mr. Zuma on stage at the memorial. "He is not like Madiba," Mr. Mikobeni said. "He only cares about himself. This man spent all our money on his house, so many millions," he continued, referring to \$27 million on so-called security upgrades to Mr. Zuma's home, which were paid for with government money but included things that had nothing to do with security, according to a preliminary investigation.

Nepal makes diplomatic efforts to remove EC's flight ban

(Agencies) Kathmandu: Nepal is making diplomatic efforts to persuade the European Commission to revoke its recent decision to ban all Nepali airlines from entering the European airspace, government officials said Tuesday. "The EC's recent decision could damage Nepal's aviation sector and this is the reason (why) we are using our diplomatic tools within this week to woo EC to roll back its decision," Xinhua quoted aviation ministry spokesperson Mohan Krishna Sapkota as saying. In a statement last Thursday, the EC had put all

of Nepali air carriers on the EU air-safety list -- a move that will effectively bar Nepali planes from flying into European countries. "Surprisingly, we have neither received confirmation from the EC so far nor have been informed as to on what basis our aircraft has been put on the air-safety list," the spokesperson added.

Ministry officials said it would be wise to use diplomatic channels to persuade the EC to reconsider or withdraw its decision before it sends the formal confirmation to the Nepali government. "We will first discuss with our foreign ministry about the sensitivity of the issue and ask it to mobilise its Brussels-based embassy to take care of the issue," Sapkota said.

Ministry officials claimed that it was unfair for the EC to blacklist Nepal's air carriers unilaterally without evaluating the country's air safety state shown by the International Civil Aviation Organisation (ICAO) audit.

Nepal's non-compliance rate under the ICAO standards declined by 12 percentage points to 45 percent, while the global figure dropped to 39 percent

last year. "While the IACO audit report is yet to come for this year, the EC has hastened to blacklist Nepal's aircrafts," said a ministry official who declined to be named. "The reason behind this is something else rather than the core safety issue."

Meanwhile, the ministry said the EC's decision would not affect Nepal's decision to purchase Airbus planes. In April this year, Nepal's national flag carrier paid \$500,000 to Airbus as the earnest money to buy two A320-200 aircraft.

Khobragade was charged with one count of visa fraud and one count of making false statements, which carry maximum sentences of ten years and five years in prison, respectively. She is expected to appear before US Magistrate Judge Debra Freeman.

electronically submitted an application for an A-3 visa, which is a US visa for domestic workers and servants, through the website for the US Department of State's Consular Electronic Application Center for an Indian national who was to be the personal employee of Khobragade beginning in November 2012 in New York.

The Visa Application stated that the Indian worker employed by Khobragade was to be paid USD 4,500 per month. According to an employment contract. Khobragade would pay the domestic help the prevailing or minimum wage, whichever is greater, resulting in an hourly salary of USD 9.75. However, the domestic help worked for Khobragade as a household employee from approximately November 2012 through approximately June 2013. The domestic help worked far more than 40 hours per week and was paid less than USD 9.75 per hour

Indian Embassy in Washington on Dec 13 2013 also released a Press Statement on it's website stating that " We were informed that Deputy Consul General of India in New York. Dr. Devvani Khobragade, was taken into custody by law enforcement authorities in New York in the morning of December 12, 2013 while she was dropping her daughter at school. Dr. Khobragade was later released that same evening.

Action was apparently taken against Dr Khobragade on the basis of allegations raised by the officer's former India-based domestic assistant, Ms Sangeeta Richard, who has been absconding since June this year. In this context the Delhi High Court had issued an-interim injunction in September to restrain Ms Richard

proceedings against Dr Khobragade outside India on the terms or conditions of her employment. The US Government had subsequently been requested to locate Ms Richard and facilitate the service of an arrest warrant, issued by the Metropolitan Magistrate of the South District Court in New Delhi under Sections 387, 420 and 120B of the Indian Penal Code. The Embassy of India in Washington DC had immediately conveyed its strong concern to the U.S. Government over the action taken against Dr Khobragade. The US side have been urged to resolve the matter with due sensitivity, taking into account the existing Court case in India that has already been brought to their attention by the Government of India, and the Diplomatic status of the officer concerned.



(Agencies) DHAKA: Bangladesh's cricket chief has said that next year's World Twenty20 is threatened by the country's deadly political violence, warning there may only be weeks to save the tournament. The 16-team competition

due to take place between March 16 and April 6, should be the biggest sporting event ever staged by Bangladesh.

But the country has been gripped by violent protests in recent weeks, with opposition supporters insisting that Prime Minister Sheikh Hasina stand aside ahead of elections due next year. More than 74 people have been killed since late October. "If this situation prevails, then any big tournament or participation of any big country will be under threat," Bangladesh Cricket Board (BCB) president Nazmul Hassan told reporters late Monday.

'This must end in January and preferably in December."A team of International Cricket Council (ICC) inspectors declared last week that they were "happy" with security arrangements but said they would continue to monitor the situation. However, the dangers posed to teams was underlined at the weekend when a small bomb exploded outside the West Indies' Under-19 team's hotel in the port city of Chittagong, prompting them to cut short their tour. Obama Reaches Out to Cuba's Leader, but the Meaning May Elude Grasp

(Contd from page 1) But the image - captured by photographers and television cameras instantly raised questions about its deeper meaning. Was Mr. Obama trying to signal a new effort by the American government to reach an accommodation with Cuba 50 years after the Communist revolution that put Fidel Castro, Raúl's brother, in power? Or was Mr. Obama simply trying to avoid delivering a diplomatic snub at a memorial dedicated to forgiveness? The president's aides would have known in advance which world leaders would be at the podium when the president approached for his own remarks. But White House officials declined to offer any explanation of the handshake or confirm that there had been a discussion about whether to offer one

Still, Mr. Obama's own remarks, delivered just moments afterward. offer tantalizing possibilities about what was going through the president's mind when he approached Mr. Castro.

Mr. Obama talked about the need for trust and reconciliation and forgiveness. He was talking about Mr. Mandela — widely known by his clan name, Madiba — but his remarks might also apply to the diplomatically frozen relationship between the United States and Cuba.

The question is whether Mr. Obama was trying to signal a desire to change hearts by shaking Mr. Castro's hand. If so, the Cuban president would become the latest adversary that Mr. Obama has sought to turn into a friend - or at least a less dangerous opponent. Mr. Obama's efforts to negotiate a nuclear deal with Hassan Rouhani. the Iranian president, are another example.

A handshake like the one Mr. Obama offered Mr. Castro has the potential to become a political problem for the president, much the way that Mr. Obama's handshake in 2009 with Hugo Chávez, then the Socialist president of Venezuela, was criticized by Republicans.

Mr. Obama was also attacked for bowing to Emperor Akihito of Japan that year. That was 20 years after President George Bush generated criticism by bowing at the coffin of Emperor Hirohito, Japan's wartime leader Mr Obama was accused of bowing to King Abdullah of Saudi Arabia during a meeting of world leaders in 2009, something the White House denied.

But such a gesture can also mark the beginning of a thawing of relations, something many Cuban-Americans would be wary of. In his remarks. Mr. Obama hinted that he was seeking a world not defined by old animosities. It is not too much of a stretch to think that he was talking about the Cuban-American dynamic for the past half-century. "South Africa shows we can change, that we can choose a world defined not by our differences, but by our common hopes." Mr. Obama said at the memorial. "We can choose a world defined not by conflict, but by peace and justice and opportunity.'



Sri Lanka rally to protest against disappearances

(Agencies) Hundreds of Sri Lankans have held a demonstration in Colombo, demanding to know the whereabouts of two activists who disappeared two years ago.

Lalith Weeraraj and Kugan Muruganathan organised rallies against political disappearances before being apparently abducted in the north of the country.

The rally was held on the second anniversary of their disappearance.

The crowd blamed the government and security forces, but they have always denied involvement. Another demonstration on human rights, in the east of the country, was attacked by government supporters leaving one of its organisers injured: he was admitted to hospital. Sri Lanka has one of the world's highest tallies of disappeared people the United Nations says there are more than 5,000 cases, and that number refers only to those that have been registered.

Many of these date from the 1980s and 1990s but activists say hundreds of people, mostly ethnic minority Tamils, disappeared at the time of the government's war victory against the Tamil Tigers in 2009, including many who

apparently vanished after surrendering to government forces or crossing to government-held territory.Release Lalith and Kugan and stop abductions and torture," the crowd shouted at Tuesday's demonstration outside the main railway station.

Lalith Weeraraj and Kugan Muruganathan vanished near Jaffna while preparing a demonstration to mark World Human Rights Day in 2011. Among placards held by the 500-odd protesters were depictions of white vans - a type of vehicle regularly associated with shadowy abductors - with the word "DON'T!" underneath

"Lalith is my only son. I believe he is still alive," his father, Arumugam Weeraraj, told the BBC. "He did nothing wrong. He was helping suffering parents.' He said his son, half-Tamil and half-Sinhalese, was well placed to help in such situations being fluent in both languages. Pubudu Jayagoda, a spokesper-

son for a leftist group under which the two men were working, said that because the two had been abducted in a high-security zone "we believe the government should be responsible for this and the security forces are responsible for this".He alleged that their motorbike had later been found in a police station

The Nobel Peace Prize-winning International Physicians for the Prevention of Nuclear War and Physicians for Social Responsibility released an initial peer-reviewed study in April 2012 that predicted a nuclear famine could kill more than a billion culated that the world's most populous country would face severe food

"A billion people dead in the tastrophe unparalleled in human history. But then if you add to that the possibility of another 1.3 billion people in China being at risk, we are entering something that is clearly the end of civilization," said Ira Helfand, the report's author.

Helfand said that the study looked at India and Pakistan due to the longstanding tensions between the nuclear-armed states, which have fought three full-fledged wars



since independence and partition in 1947. But Helfand said that the planet would expect a similar apocalyptic impact from any limited nuclear war. Modern nuclear weapons are far more powerful than the US bombs that killed more than 200,000 people in Hiroshima and Nagasaki in 1945.

"With a large war between the United States and Russia, we are talking about the possible, not certain, but possible, extinction of the human race. "In this kind of war, biologically there are going to be people surviving somewhere on the planet but the chaos that would result from this will dwarf anything we've ever seen," Helfand said.

The study said that the black carbon aerosol particles kicked into the atmosphere by a South Asian nuclear war would reduce US corn and soybean production by around 10 percent over a decade. The particles would also reduce China's rice production by an average of 21 percent over four years and by another 10 percent over the following six years. The updated study also found severe effects on China's wheat, which is vital to the country despite its association with rice.

China's wheat production would plunge by 50 per cent the first vear after the nuclear war and would still be 31 per cent below baseline a decade later, it said. The study said it was impossible to estimate the exact impact of nuclear war. He called for further research, voicing alarm that policymakers in nuclear powers were not looking more thoroughly at the idea of a nuclear famine.But he said, ultimately, the only answer was the abolition of nuclear weapons.

"This is a disaster so massive in scale that really no preparation is possible. We must prevent this," he said.







SEOUL - North Korea announced Friday that it had executed the uncle of leader Kim Jong Un, calling him a "traitor for all ages" who opposed Kim's rule and

plotted his overthrow. Jang Song Thaek was executed after admitting to his crimes before a military tribunal Thursday, the North said in a statement released by the state-run news agency. The North said Jang, in attempting to realize his "wild ambition" of supreme power, was "despicable human scum" and "worse than a dog." Jang's execution comes just days after he was stripped of all his positions and removed from Kim's small inner circle of advisers. The purge, documented by the North with unusual detail, marks the most significant leadership change since Kim took power

ago and suggests that he is willing to publicly go after rivals in ways that his more secretive father never did.

In recent days, the North had accused Jang of everything from graft to gambling to womanizing. But the North's account Friday narrowed to a more serious charge, saying that Jang had contested the country's system of passing power from father to son. In 65 years of Kim family rule, never has the North so explicitly described high-level dissent.

The North said Jang, a lifelong politician, had quietly followed marching orders under the nation's founder, Kim II Sung, and his son Kim Jong II. But after Kim Jong II's death in December 2011, Jang made his move, "overtly and covertly

Soon after the counting began, Sheila Dikshit, foreseeing her defeat in the polls, resigned from the post of Delhi chief minister.

Dikshit suffered a humiliating defeat and lost her seat in New Delhi constituency to debutant Aam Aadmi Party's Arvind Kejriwal by a margin of 25,864 votes

SHEILA Dikshit's political fortunes came crashing in the Assembly elections, billed as a litmus test for the Congress ahead of the 2014 Lok Sabha polls, which witnessed the first-ever triangular contest in Delhi. The Congress and the BJP had been the traditional rivals since 1993. However, the Aam Aadmi Party's entry into the political arena changed the scenario in the Capital.

With Dikshit losing from her own constituency in New Delhi at the hands of AAP chief Arvind Kejriwal, the future of the three-time chief minister appears to be uncertain. Dikshit was the lone face of the Congress in Delhi, except for a few fleeting appearances of Sonia and Rahul Gandhi, as she carried the burden of the poll campaign. She was among the few Congress leaders who ruled uninterrupted for 15 years. Political experts even said that she could have been the party's potential PM candidate in the future.

Though she bit the dust, analysts said credit cannot be taken away from Dikshit for ushering in reforms in the power sector, introducing egovernance in various departments and launching a series of social security schemes besides significantly enhancing the city's infrastructure.

When asked if the Congress had failed to gauge the mood of the people of the city, which it had ruled for the last three terms, Dikshit retorted, "Bewakoof hain na (we are idiots, right)?" Incidentally, ahead of the elections, Dikshit had said, "Kejriwal is not even on our radar." The party could not have expected the scale of drubbing that came as a bolt from the blue as entry of the Aam Aadmi Party altered the political landscape in the national capital.

Dikshit (75), the longest-serving woman CM in independent India, could not win a fourth term in office.

Parole order for Sanjay Dutt sparks protests

(Insider Bureau) A MAJOR controversy has erupted over granting parole to Bollywood actor Sanjay Dutt. The parole will allow him to leave prison for a second time in a little over a month. The decison has drawn stiff opposition from various quarters.



(Insider Bureau) NEW DELHI: Star India has won the bid for the Indian cricket team's logo sponsorship rights from 2014 to 2017 for Rs 1.92 crore a match, a drop of 40% from Rs 3.34 crore, a match that current sponsor Sahara is paying but 28% higher than the base price of Rs 1.5 crore. The bids indicate that cricket sponsorship rates are regarded as overpriced, amid the rising popularity of several other forms of sports on television including football, hockey and badminton, experts said.

Sahara, which had decided

not to renew its sponsorship contract with the Indian cricket board, had nevertheless submitted a bid after picking up the tender documents along with others such as Sony, Games Unlimited, UB Group, Airtel and World Sport Group India.

The Board of Control for Cricket (BCCI) in India said only Sahara and Star submitted bids for the logo rights but "Sahara's bid was found to be ineligible," even though it bid Rs 2.35 crore per match, putting an end to a 12-year relationship between the two "Star is the title sponsor for BCCI international and domestic matches for the period October 2013-March 31, 2014, as well as the holder of the broadcast, internet and mobile rights of cricket in India, for the period July 2012-March 2018.

Star has a deep understanding of the game of cricket and what it means to the nation. We are pleased to extend our association with them," said BCCI secretary Sanjay Patel.

Wash. — Riveters once ruled here, as Boeing airplanes rolled off the line and into the sky from giant factories where rivers of aluminum were pounded into form and function. And Boeing, founded in nearby Seattle in 1916 in the era of the Sopwith Camel, returned the favor, building up the Puget Sound region as a blue-collar powerhouse from the 1940s through the commercial jet age. Almost half of the company's 171,000 employees still call Washington State home.

But the next chapter of that old relationship has become a cliffhanger of politics, economics and perhaps, some suspect, brinkmanship and bluff. Where the company will assemble its next generation of commercial airplane, the 777X — which only a few months ago looked lockeddown certain to be right here — is now up for grabs, with a national scramble of states and cities bidding for Boeing's hand with tax breaks, incentives and promises of labor congeniality.

A WAR HERO REIRES

(Insider Bureau) THE curtains are going to fall on one of the Indian Air Forces' (IAF) most glorious chapters next week when Mig- 21 FLs (type 77) will be airborne one last time soaring their way into history.

It will also mark the beginning of the end of half a century old era of Mig- 21 operations in the IAF. IAF chief NAK Browne will be in Kailaikunda in West Bengal on December 11 to take salute from four Mig- 21 FL aircraft that will fly a " box formation" as their last sortie.

The IAF will say bid adieu to the aircraft that has flown over 50 years, which itself is a tribute to the machine and the men who kept it going.

The Mig- 21 FLs would fly in the company of another ageing platform from the Mig stable — Mig- 27 MI — and the latest Sukhoi- 30 MKIs.

The aircraft ushered in the supersonic era into the IAF. It was assigned secondary missions after the induction of Mirage 2000s in the 1980s which were now being used for training pilots.

An IAF statement said that the first ever air combat in the subcontinent took place in 1971 between a Mig- 21 FL and Pakistan Air Force's F- 104 Stratfigher.

In terms of kills in the 1971 war, the Mig- 21s scored with four F- 104s, two F- 6s, an F- 86 Sabre and a C- 130 Hercules of PAF. One of the high points of air operations in 1971 war was the attack on the governor's house at Dhaka which proved to be a decisive event forcing Pakistan to surrender.

After the 1971 war, the Mig-21s were also used in the air operations during the Kargil war.

The Mig-21 FL was followed by other versions of the aircraft including M/ MF (type 96), Bis and the most recently upgraded Bison. The IAF has begun phasing out of its Mig- 21 squadrons. The last surviving MiGs will be the Bisons which are expected to remain in service even beyond 2020 because of delays in replacements.

'IT WAS LIKE DRIVING A SPORTS CAR'

(Insider Bureau) IT WAS like driving a sports car," said Air Commodore (retd.) Suren Tyagi talking about Mig-21 FL which will go into aviation history next week after being phased out by the India Air Force (IAF).

With 6,316 sorties and 4,003 hours of flying to his credit, no one in the world seems to have flown the Mig- 21s more than Air Commodore Suren, and a major chunk of these flying hours were logged on Mig-21 FL. Speaking to Mail Today, Suren said the Mig-21 FL was undoubtedly his most favourite aircraft. It was also the most tricky to control, he said talking about its character of being unsparing. The aircraft had come with modifications from its earlier version. It had a drop tank which was an addition and rocket pods, air commodore Suren said. The Mig-21 FL was an interceptor but the IAF had modified it for ground attack role. All the famous strikes in and around Dhaka in the 1971 war was carried out by Mig-21 FL, he said

The handling of the aircraft was smooth as it responded well to the controls. It was like driving a sports car because of uninterrupted view from the front opening canopy. Air commodore Suren said in terms of capability, it was the finest variant of Mig- 21 the later versions, however, had better radars and more power. He said that the aircraft even got better off the Mirage-2000 once in the late 1980s during an air combat mission. There was no room for messing up in the cockpit as there was no scope of recovery, said the veteran pilot. It is creditable that the aircraft has flown for 50 years. The IAF had to stop flying these aircraft because it was not possible to continue operations with lack of spare support. The aircraft is not flown anywhere in the world. IAF's squadron 28, which now flies Mig- 29s, was the first supersonic squadron. Air commodore Suren belonged to 4 squadron, one of the oldest in the IAF, which continued to fly Mig- 21 FLs. The veteran pilot is felt nostalgic about the phasing out of the aircraft which commanded respect.







India's gay rights activists described Wednesday as a "black day," following a judgment by the country's Supreme Court that overturned an earlier ruling decriminalizing homosexuality.In 2009, in what was considered a historic judgment, the Delhi High Court decriminalized homosexual intercourse between consenting adults following a petition filed by Naz Foundation. a non-governmental organization that works in the areas of HIV/ Aids and sexual health. Naz had challenged the Indian Penal Code's Section 377, introduced during British colonial rule which criminalized sexual activity "against the order of nature" and stated a maximum sentence of life imprisonment.But Wednesday's Supreme Court judgment has set aside the 2009 Delhi High Court order, observing that Section 377 "is a valid constitutional provision." The judgment also stated that any changes in Section 377 can be made through legislation referring the matter to Parliament since "the judiciary has no role in it." The Supreme Court bench also said Parliament is authorized to delete section 377, but while the penal provision exists,



kind of sexual relationship." "What does this say of us as a culture, as a people? This is really very sad. It is taking us a 100 years back," Naz foundation member Anjali was quoted stating in local reports. "This is a black day for all of us citizens of modern India; we are very disappointed by the verdict," added Amnesty International India executive chief G. Ananthapadmanabhan, "It is going to be a long and uncertain route now. There's no doubt that a historic move has been lost." But some religious figures and groups have welcomed the judgment, such as well-known yoga quru Baba Ramdev, who has strongly opposed homosexuality. "The court has respected the sentiments of millions of Indians and declared homosexuality a crime," he said.All India Muslim Personal Board member Zafaryab Jilani -- who was among the petitioners in the Supreme Court -- said the judgment "has been done to keep our culture

intact. This has been done to respect all religions." But leading Bollywood celebrities expressed disappointment at the verdict as they shared their views on social media. "Freedom is such a deceptive term. Rights are an ambiguous mystery," actress Anushka Sharma posted on Twitter. "Its frightening how someone else decides how when and who you should love -- basically freedom of choice isn't legal anymore," posted actress Shruti Haasan. "Only a

highly uninformed mind can have [the] arrogance of assuming that consenting adults having sex is any of their business" tweeted director Anand Gandhi (Ship of Theseus). "The Supreme Court got it wrong today," tweeted actor-director Farhan Akhtar. Actress Mia Farrow also shared her views posting a series of tweets: "Canceled trip to India. My wife and I would not feel welcome there... Wellwhen I have a wife- we won't be going to India."
